SECTION 1. TITLE

This shall be known as Local Law 1 of the year 2024 a local law to expand the residency requirements to fifty (50) miles for the Trustees of the Williamstown Library.

SECTION 2. AUTHORITY

This local law is adopted pursuant to the Municipal Home Rule Law and Public Officers law Section 3 that grants to local governments the authority to enact local laws regarding the qualifications of local officers.

SECTION 3. RESIDENCY REQUIREMENTS FOR LIBRARY TRUSTEES

The residency requirement for the persons being appointed to the office of Trustee of the Williamstown Library shall be expanded to allow for residency within fifty (50) miles of the Williamstown Library.

SECTION 4. EFFECTIVE DATE

This local law shall take effect upon the filing in the office of the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law.

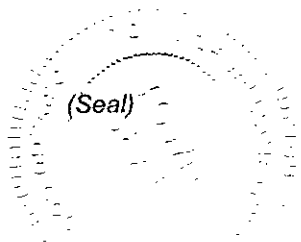
